The PHE Group (Autodistribution) is consolidating its presence in Spain with the acquisition, via AD Parts Intergroup, of AD FRECO Parts in Catalonia.

AD FRECO Parts is a leading independent distributor of spare parts for light vehicles in the province of Tarragona (in the south of the Community of Catalonia). A family-owned company, AD FRECO Parts was founded in 1979 and joined the AD network in 1996. It has nine sales outlets across southern Catalonia, including a central warehouse in Reus, where the company's head office is also located. AD FRECO Parts generated sales of more than €24 million in 2024 and employs 145 people.

Present in Spain since 2019, the PHE Group, through AD Parts Intergroup, now covers the provinces of Girona, Barcelona, Navarre, Rioja, Castellón, Murcia, San Sebastian, Valencia, Biscay, Álava, Lleida, Huesca, Andorra and, now, Tarragona.
